Our association would like to express our thanks to both the City of Dunedin and FEMA for the excellent job they did with storm debris cleanup on November 11, 2024. The City had originally determined that our community was not eligible for this service at no cost to us because our roads are private, however, they later changed their policy resulting in a savings of at least \$3,000 for our community!

Storm Debris – What To Do

In light of the back-to-back hurricanes our area sustained this fall, some clarification on how to manage storm debris was requested.

- 1. If you sustain damage, you should report it to our management company (contact info is below).
- 2. Next, clear the roadways and storm drains of sticks and branches. These can be placed in piles along the main roadways where trash is collected.
- 3. Leaves and small branches should be bagged and put out with regular trash the city will pick up these items once regular trash service resumes.

GENTLE REMINDERS:

Leasing Cap of 25% and Leasing Restrictions:

Residents are reminded that Willow Wood Village has a Leasing Cap of 25% of the total units. Given that THE 25% CAP HAS BEEN REACHED, any owner wishing to lease his or her lot shall inform our property manager (in writing) and shall be placed on a first-come first-served waiting list. Detailed information about the community Leasing Restrictions is found on the SALES & LEASING tab of our website.

Monthly Maintenance Fee Payments: (Fee increases to \$230/month January 2025)

We still have far too many residents who are delinquent in their monthly assessment payments to the Association. Your Association will continue to be diligent in applying late fees to all delinguent accounts. When delinguent accounts reach a certain point, the Association places a lien on the property which could ultimately lead to foreclosure. Property Inspections:
